

MINUTES OF THE MEMBERSHIP MEETING
OF THE MODEL T FORD CLUB OF GREATER ST. LOUIS
FRIDAY, AUGUST 8, 2025

The meeting was called to order at 8:00 p.m. by President Steven Williams.

After discussion, Keevin Schier made a motion to have \$600.00 in the budget for desserts. The motion was seconded by Dave Beckerer. Steven Williams stated that the work Daniel Mullis does for the Club is appreciated. The motion carried. Bonnie Dattoli restated that the Board should discuss this first.

Keevin Schier suggested going to a Tech event and maybe also have a dinner to find other ways to make money for the Club.

Steven Wiliams suggested going to a person's house to see their cars. There was also a suggestion by Bonnie Dattoli that the members have a progressive supper. A decision was made by a show of hands

Steve Dodson suggested that the Club might have a car show where the Club has meetings and invite people on the outside.

Keevin Schier spoke about the event that will be at the Fox Schools grounds.

It was mentioned that rent for the meetings is \$1,980.00 per year.

Mike Thum spoke about his car, and trouble he is having with a spring.
